Two years ago the MIS Quarterly published a listing of MIS dissertations written between 1973 and 1980. This list has now been updated. A list of new dissertations will be published annually in the MIS Quarterly to provide a complete, up-to-date index to the MIS dissertation literature.

The method used for identifying dissertation titles was previously described and validated.¹ Although this method ensures identification of most MIS dissertations, there will be occasional oversights. Undoubtedly, there are some we have missed this year and still others from previous years. We encourage additions to the bibliography.

Abstracts of the dissertations are found in Dissertation Abstracts International, which is available in most university libraries.² The 500 to 1,000 word abstracts provide a short description of the research topic, research methodology, and findings.
